## SUMMARY ANNUAL REPORT FOR NIAGARA BOTTLING, LLC EMPLOYEE WELFARE BENEFIT PLAN

This is a summary of the annual report of the Niagara Bottling, LLC Employee Welfare Benefit Plan, a health, life insurance, dental, vision, temporary disability, prepaid legal, long-term disability and death benefits plan (Employer Identification Number 33-0843510, Plan Number 503), for the plan year 03/01/2018 through 12/31/2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Niagara Bottling, LLC has committed itself to pay certain medical claims incurred under the terms of the plan.

## **Insurance Information**

The plan has insurance contracts with Vision Service Plan, Delta Dental of California, Pre-Paid Legal Services Inc. dba LegalShield, Aetna Health, Inc., Aetna Life Insurance Co. And Kaiser Foundation Health Plan Inc. to pay certain Vision, Dental, Legal, Health, Prescription drug, HMO contract, Life insurance, Temporary disability, Long-term disability, Accidental Death & Dismemberment, Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2018 were \$8,124,805.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2018, the premiums paid under such "experience-rated" contracts were \$452,446 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$271,567.
